22. Privately Managed Disability Housing for ages 18-49 years of age, often in same buildings as # 22, above. Applicant is eligible but t
23. Ex-Offender Housing | Halfway Houses | Private Landlords with arrangements with County Sheriff
24. Privateley Managed Subsidized and Affordable Housing, Federally-funded
25. Privately Managed Subsidized and Affordable Housing, State-funded
26. HIV-population housing
27. Homeownership for First-Time buyers or Local Residents only
28. Non-Profit Managed Housing, Federally-funded, overlap with 2, 3, 5, 9, 22, 24, 25 - sometimes in same building as 29.
29. Non-Profit Managed Housing, State-funded, overlap with 2, 3, 5, 9, 22, 24, 25 - sometimes in same building as 28.
30. Privately Managed Housing, using MRVP Mobile Voucher
31. Privately Managed Housing, using AHVP Mobile Voucher
32. Privately Managed Housing, using Section 8 Mobile Voucher
33. Inventory in Bordering States (often more reachable than housing in same state, more distant)
34. Mobile Home Parks - affordable rentals and homeownership, can sometimes use mobile voucher
35. Permanent Sober Housing
36. USDA Rural Subsidized Housing - created by a federal farming agency
37. Private Small Landlords (less than 200 units) who charge lower than market rents.
38. Section 8 Designated Housing for Individuals with Disability who are under 62
39. Section 8 Mainstream Housing for families including a person with disability, any age
40. Section 8 mobile vouchers, available form two different "centralized lists" and some other sources not participating
41. MRVP Mobile vouchers
42. MRVP Project Based units
43. AHVP Mobile Vouchers
44. VASH Vouchers
45. Temporary Assistance Programs: AHAR
46. Temporary Assistance Programs: RAFT
47. Temporary Assistance Programs: City Rental Subsidy Program
48. Temporary Assistance Programs: Rapid-Rehousing Funds,
49. Temporary Assistance Programs: Homeless Prevention Funds
50. Veterans Housing Programs, Federal and State-funded, listed in local City Hall offices
51. Shelters and Transitional Programs, usually over-capacity most nights, with no centralized listing of open beds across the state
52. Hospital Clinical Trials offering short-term housing for the term of the clinical trial
